# CTS-I Application Eligibility - Recognized Course List

The CTS-I Application requires eligibility verification in six skill-related areas as listed in the CTS-I Candidate Handbook and in the CTS-I Application Form. For each of the six skill-related areas there are several options for verification.

One option is by successfully completing a course that is recognized as meeting the minimum requirements as listed in each of the six skill-related areas below. For a course not previously recognized, candidate must submit a copy of the course title and learning objectives along with a copy of the course completion document with their application. Organizations with training programs who wish to have their program evaluated for inclusion in the list below, please email certification@infocomm.org.

**Note:** For courses that are not included in the recognized list, in addition to the course completion copy, the applicant must attach course title and learning objectives for the skill area with the application.

Another option is verification by the signature of a person other than the applicant who has personal knowledge of the applicant's experience within that specific area. For further information on this option see the CTS-I Application Eligibility – Verifier List

Applicants are strongly urged to refer to the examination blueprint found in the CTS-I Candidate Handbook for details regarding the level of skill and knowledge required to earn the CTS-I. The CTS-I Exam Application contains instructions on documenting experience requirements.

#### **Skill Area – Termination Experience – Verification Checklist**

- Solders connectors resulting in a shiny appearance with good wetting and flow
- Applies heat shrink for proper strain relief and to prevent future short circuiting
- Selects correct termination materials
- Measures for appropriate connectivity

# Skill Area - Rack Build Experience - Verification Checklist

- Builds racks from technical drawings

- Calculates and applies throw distances for specific projector installation

# Skill Area - Audio Setup and EQ Experience - Verification Checklist

- Measures signal-to-noise ratio at various test points in an audio system
