## **Presentation Topic**

Presenters can submit to present on a variety of industry topics or submit their own unique topic for consideration. All presentations will be 20 minutes. We recommend planning on 15 minutes for presenting and five (5) minutes for questions.

#### **Terms and Conditions**

These terms and conditions are applicable to all individuals that submit a presentation proposal to AVIXA, Inc. in order to apply to be a presenter at Integrated Systems Europe 2020 (ISE 2020) which will take place at the RAI Amsterdam in the Netherlands.

#### Presentation Requirements:

a. To present a FlashTrack session or collaborative work at ISE 2020, the Presenter must be a current member of AVIXA (Basic membership or above) and registered for the conference before 31 December

2019. Companies submitting proposals must be ISE exhibitors with space on the trade show floor. Event registration is available through <u>www.iseurope.org</u>, and membership through <u>membership.avixa.org</u>.

b. One session per Presenter will be accepted initially (to ensure greatest diversity of topics and presenters). However, additional presentations will be considered.

c. Presentation proposals will be reviewed and selected by a team of AVIXA representatives. Selected presenters will be notified by email.

d. If the approved presentation topic includes information about or in connection with a project for which the Presenter is not the sole owner (i.e., other individuals and/or companies share ownership), the Presenter must obtain the individual or company's consent to present on the topic and to include information about the jointly owned project.

e. Presenters may request as part of their presentation proposal that up to two (2) additional presenters (Co-Presenter) be approved to participate in the presentation. AVIXA will approve up to a total of three (3) persons maximum, including the original Presenter. Co-Presenters must complete all requirements of a Presenter as outlined in the 'Primary Presenter Information' section of the guidelines.

f. Presenters agree that AVIXA may share their presentation in PDF format following ISE 2020 with session attendees. Presentations shall not be marked 'confidential' nor will any obligations of confidentiality be required of session attendees. Presenters acknowledge and agree that presentations may not include any confidential information of the Presenter/Co-Presenter or of their employer.

g. Presenters agree to the following presentation requirements:

- Presentations will consist of 15 minutes of content and will include five (5) minutes for open Q&A.
- Presentations will not include any sales presentations, pitches, or promotions.
- Presenters are not permitted to add any additional Co-Presenters without prior approval from AVIXA.

h. Any Presenter who is unable to attend must notify AVIXA immediately and use their best efforts to arrange for another qualified individual to present in their place on the approved topic.

i. Each Presenter and/or Co-Presenter are responsible for travel expenses, including hotel, airfare, ground transportation, and meals.
